## TRANSITION FROM PCR RRT INTO EMPLOYER-LED SELF SWAB SUPERVISION (ESSS) ART AND REVISED COVID RESPONSE PROTOCOLS

This circular will supersede JP Circular 73 of 2021.

### Revised Swab Requirements for all Personnel Entering JP Premises

- 1. As the nation is transiting into the mode of living with COVID-19, one of the key changes announced by the Multi-Ministerial task force on 9 October 21 was that PCR testing will only be administered for people who are unwell and showing symptoms of COVID-19.
- 2. As such, all current 7 days RTT PCR and 14 days RRT PCR for both Zone 1 and Zone 2 personnel respectively will be ceased with effect from 1 November 21. This will be replaced instead with the ESSS ART. Please refer to Annex A for the details and frequency of the ART required for the various personnel operating within Zone 1 and 2.
- 3. The supervised self-swab ART services at the designated ART center at Pass office carpark will also cease its operation from 1 November 21. All stevedores and Port Users are required to commence ESSS for their respective staff entering into JP premises from 1 November 21.

# Revised Response for Covid Positive (C+ve), ART Positive (AG+ve) or Suspected Cases

4. Ministry of Health (MOH) has simplified and re-calibrated the healthcare protocols with respect to Covid-19 cases with effect from 11 October 21. Refer to Annex 2 for the 3 Protocols to follow in the event of a positive test result is being received.




#### **ANNEX B**

#### Protocol 1: I am Unwell

- Visit SASH Clinic. Access <u>Flu Go Where</u> to establish the nearest SASH clinic to you.
- Self isolate at home after taking the PCR test and await instructions from MOH.
- Notify your immediate reporting supervisor and supervisor to notify Covid -19 team.
- Reporting supervisor to carry out contact trace based on guidelines.
- Update Covid-19 team on any change of status for affected personnel i.e. test results of PCR, issue of IO etc.
- Reporting supervisor to check on well-being of affected personnel daily.
- Discharged from IO:
  - Vaccinated: 10 daysUnvaccinated: 14 days








#### Protocol 2: Im am Well, but tested Positive

- Do not need to undergo PCR at SASH clinic.
- Self isolate for 72hrs and administered a self test at the end of the isolation.
  Result needs to be submitted into OSCAR.
- Notify your immediate reporting supervisor and supervisor to notify Covid -19 team.
- Reporting supervisor to carry out contact trace based on guidelines.
- Update Covid-19 team on any change of status for affected personnel i.e. test results of ART, start to developed symptoms etc.
- Reporting supervisor to check on well-being of affected personnel daily.





#### **Protocol 3: Close Contacts**

- Upon receipt of Health Risk Warning (HRW) via SMS, follow instructions as stated within SMS.
- Proceed to collect ART kits from vending machine via (gowhere.gov.sg/art)
- Administered a self swab within 24hrs of receiving HRW. Enter swab result into (go.gov.sg/agsubmit).
- Do not need to additionally key swab results into Oscar for ART test result administered within the duration of HRW.
- Can leave place of residence within the duration of HRW as long as an ART self swab is administered and an AG-ve is obtained prior to leaving home.
- Dept have the flexibility to decide whether to allow staff on HRW to return or put on LOA until HRW ends.
- Reporting supervisor to carry out contact trace based on guidelines.
- Update Covid-19 team on any change of status for affected personnel i.e. test results of ART, start to developed symptoms etc.
